This is for general information to all the applicants that the following rules will be applicable for the above noted Draw of Lots:

1.0 APPLICATION FORM NUMBERS have been allotted to each applicant within the range **'000001 to 028076'.**

2.0 The allotted Nos. are of 06(Six) digits.

3.0 The last 5 **(Five)** digits of APPLICATION FORM NUMBER will be considered for the Draw of-lot, with initial number is "0" (lacs place).

4.0 There will be six tombola cages(refer video on website):

4.1 "Cage-A" will contain digits from "0" to "9" (total ten tombola balls) for drawing out the digit in the "unit" place.

4.2 "Cage-B" will contain digits from "0" to "9" (total ten tombola balls) for drawing out the digit in the "tens" place.

4.3 "Cage-C" will contain digits from "0" to "9" (total ten tombola balls) for drawing out the digit in the "hundreds" place.

4.4 "Cage-D" will contain digits from "0" to "9" (total ten tombola balls) for drawing out the digit in the "thousands" place.

4.5 "Cage-E" will contain digits from "0" to "2" (total three tombola balls) for drawing out the digit in the "ten thousand" place.

4.6 "Cage-F" will contain single digit i.e. "0" (Single tombola ball) in the "Lacs" place.

5.0 <u>Procedure for Draw of Lots:</u>

5.1 First the digit in the **"unit"** place will be drawn from **"Cage-A".** The digit coming out will be for the **unit place (within 0 to 9)** which after recording, will be put back into the cage. The digit coming out, say 3, means the digit in the "unit" place is **3**.

5.2 For the digit in the "tens" place, draw will be done from "Cage-B" in a similar manner and after recording, the number (within 0 to 9) will be put back into the cage. The digit coming out, say 4, means the digit in the "tens" place is 4.

5.3 For the digit in the "hundreds" place, draw will be done from "Cage-C". The digit coming out will be for the hundreds place (within 0 to 9), which after recording, will be put back into the cage. The digit coming out, say 1, means the digit in the "hundreds" place is 1.

5.4 For the digit in the "thousands" place, draw will be done from "Cage-D". The digit coming out will be for the thousands place (within 0 to 9), which after recording will be put back into the cage. The digit coming out, say 0, means the digit in the "thousands" place is 0.

5.5 For the digit in the **"ten thousand"** place, draw will be done from **"Cage-E"**. The digit coming out will be for the **ten thousand place (within 0 to 2)**, which after recording, will be put back into the cage. The digit coming out, say 2, means the digit in the "ten thousand place is **2**.

5.6 For the digit in the **"Lacs"** place, draw is not required as single digit is fixed as "0" from **"Cage-F"**. The digit in the "lacs place is "**0**".

5.7 After drawing this, a six digit number will be found. From the above illustration, the number thus arising is 020143. Hence the final APPLICATION FORM NUMBER of the applicant arising is 020143.

The eligible applicant bearing the first number thus selected would be assigned as **Shortlisted Applicant No.** "1" for 01 no. of vehicle as per their priority of vehicles selected at the time of submission of application forms and will be considered for further processing as per tender norms. first priority of vehicle is finished, then applicant shall be allotted next priority of vehicles & so on.

- (iii) If the number found is <u>a repeat number.</u>
